

DEVON POOL POLICY & RULES 2021

OWNER/TENANT

1. **The Lifeguard on duty has complete authority within the pool enclosure.**
2. The pool will open (weather permitting), **DAILY from 11am to 7pm** with Lifeguard present.
3. Everyone entering the pool enclosure must have a Devon photo ID and yellow Devon Pool 2021 wristband or be the guest of someone with a Devon photo ID and yellow Devon Pool 2021 wristband, **including cabana occupants.** The Lifeguard will sign in all residents and their guests. **EVERYONE IN THE POOL ENCLOSURE MUST BE WEARING AN YELLOW "DEVON POOL 2021" WRISTBAND OR PINK GUEST WRISTBAND ON THEIR WRIST (except children under 8 years old) AND PRESENT THEIR DEVON ISSUED PICTURE ID UPON ARRIVAL.**
4. Everyone **8 years and over must wear a YELLOW "DEVON POOL 2021" wristband or PINK guest wristband on their wrist,** which must be worn at all times in the pool enclosure.****GUEST WRISTBANDS MUST BE PURCHASED IN ADVANCE IN THE DEVON OFFICE**** Guest wristbands **ARE NOT** available at the pool.
5. Each unit is permitted to have a total of seven (7) people at the pool at one time – the two (2) ID holders and a maximum of five (5) guests, at least one (1) ID holder must be present.
6. **An adult must accompany every child under age 14.** Responsibility for children rests with the adult. **The Lifeguard has sole discretion to require that an adult remain within arm's length of the child when in the pool.**
7. Any child who is not potty-trained must wear ***Huggies "Little Swimmers"*** in order to enter the water. **Disposable diapers are not allowed in the pool. Disposal of diapers/Little Swimmers must be in the trash.**
8. Persons wearing suntan lotion **must** use towels when occupying a lounge or chair.
9. If pool furniture is moved, it must be returned to its original place by the person that moved it.
10. The only floatation devices permitted in the Devon pool are noodles, kick boards, and inflatable ring no more than 36 inches in diameter. Rafts are not permitted. **Water floatation devices used by children (particularly arm bands) are permitted only if the accompanying adult is within reach of that child at all times.**
11. Diving from pool deck must be in the diving area only.
12. Persons incapable of swimming two lengths of the pool with ease and confidence will not be permitted beyond the shallow end.
13. All personal injuries, regardless of how slight or minor, must be reported to Lifeguard on duty.
14. **Food or drink is not allowed in or near the pool.** These should be kept at the chairs or tables.
15. **NO SMOKING; NO RADIOS OR MUSIC;** No yelling across the pool or the pool deck. Keep cell phone calls short.
16. Cabana deck is for use by cabana renters and guests only.
17. Any act which could result in personal injury, either to oneself or to others, is prohibited.
18. **Absolutely no glass allowed** within the fenced pool area, including, but not limited to, salsa jars, salad dressing bottles, wine or beer bottles. If found to have glass in the pool enclosure, pool privileges for the unit are revoked immediately for the remainder of the season. **The unit owner will be responsible for all associated costs, if broken glass leads to clean up, including, but not limited to, emptying the pool, cleaning and vacuuming the pool, refilling the pool.**
19. Alcohol use only with signed waiver. Any guest, who intends to consume alcohol at the pool, must sign a waiver on the day of use.

- Violations will lead to ejection from the pool and pool privileges will be revoked for the duration of the pool season. Upon revocation of pool privileges, all wristbands and photo IDs must be returned to the Devon office within 3 days. Failure to return all wristbands and photo IDs associated with the unit will result in a fine of \$25 per day until those items are returned to the Devon office.
