<u>Updates for the 2021 Pool Season</u> <u>NEW THIS YEAR</u>

❖ **Alcohol Use:** We will attempt a trial period of allowing alcohol use at the pool. If we find that alcohol use is disruptive to the pool environment, the trial period will end and alcohol use will return to being prohibited.

Alcohol use only with signed waiver. Any guest, who intends to consume alcohol at the pool, must sign a waiver on the day of use.

❖ <u>Designated User:</u> Each unit will be issued two (2) photo IDs with corresponding Devon Pool 2021 yellow wristbands. The first photo ID and wristband will be issued to the unit owner. At the owner's discretion the second ID and wristband may be issued to a "Designated User". The only exception will be when an owner assigns both photo IDs to a legal tenant(s) of their unit.

A "Designated User" may be anyone the unit <u>owner</u> chooses. The "Designated User" ID and wristband is for the entire season. A subsequent "Designated User" will not be allowed. The owner accepts full responsibility for the designated user's actions and behavior. The "Designated User" must complete all applicable pool user acknowledgements. Any violation of the Devon pool rules by a "Designated User" will result in revocation of pool privileges for the UNIT for the entire 2021 pool season. Upon revocation of pool privileges, all wristbands and photo IDs must be returned to the Devon office within 3 days. Failure to return all wristbands and photo IDs associated with the unit will result in a fine of \$25 per day until those items are returned to the Devon office.

Tenants may not have a "Designated User".

The person presenting the Devon issued photo ID and yellow "Devon Pool 2021" wristband to enter the pool area **must be the person pictured on the photo ID.** You may not hand off your Devon ID and wristband for others to use.

- Glass: Absolutely no glass allowed within the fenced pool area, including, but not limited to, salsa jars, salad dressing bottles, wine or beer bottles. If found to have glass in the pool enclosure, pool privileges for the unit are revoked immediately for the remainder of the season. The unit owner will be responsible for all associated costs, if broken glass leads to clean up, including, but not limited to, emptying the pool, cleaning and vacuuming the pool, refilling the pool.
- Guest Wristbands: Guest wristbands will now be PINK and they will cost \$4.50. All guests must be accompanied by someone with a Devon issued photo ID and yellow "Devon Pool 2021" wristband. You must remain at the pool with your guest. Everyone 8 years and over require a guest wristband, which must be worn at all times in the pool enclosure. **GUEST WRISTBANDS MUST BE PURCHASED IN ADVANCE IN THE DEVON OFFICE** Guest wristbands ARE NOT available at the pool.

Anyone with blue guest wristbands left over from last year may exchange them at the Devon office for new PINK guest wristbands.

❖ Floatation Devices: The only floatation devices permitted in the Devon pool are noodles, kick boards, and inflatable rings no more than 36 inches in diameter. Rafts are not permitted. Water floatation devices used by children (particularly arm bands) are permitted only if the

accompanying adult is within reach of that child at all times. at the Devon pool office.	Floatation devices cannot be stored
